Administrator's Quarterly Report for the YDC Claims Administration and Settlement Fund 2023 Quarter Two

The New Hampshire Legislature established the YDC Claims Administration and Settlement Fund under NH RSA 21-M:11-a, for victims of sexual and physical abuse at New Hampshire's youth detention center facilities in prior decades to provide an administration process as a trauma-informed, victim-centered alternative to litigation for the efficient and fair resolution of potential claims against the State of New Hampshire. 2022 HB 1677, *Statement of Purpose* for NH RSA 21-M:11-a.

This Quarterly Report is provided by Administrator Broderick pursuant to his duty under the statute to provide information, in consultation with the Attorney General's Office, about claims filed and anticipated to be filed, as well as administrative costs paid and anticipated. NH RSA 21-M:11-a, XV.

The claims process has further developed throughout Quarter Two. Yet, portions of claims processing, particularly Resolution Proceedings with the Administrator, are in the inception stage as Quarter Three begins. This Report has a modified presentation as compared to the Quarter One Report to provide further detail and clarification. The Administrator and the Attorney General's Office will continue to contemplate how to develop future reports to provide projections about claims and anticipated payments.

<u>For information about claims</u>, the statute requires reporting for the following data: the number and nature of claims made and settled, the amounts requested and paid in settlement to date, the claim amounts pending, an estimate of the likely amounts which will be approved and paid. NH RSA 21-M:11-a, XV.

For information about costs, the statute requires reporting for the following data: costs which have been paid from the Fund, and an estimate of future costs to be paid. NH RSA 21-M:11-a, XV. Costs from the Fund include payments for resolved claims (including fees and costs of attorneys who represent claimants), costs for claims processing by the Claims Administrator ("CA"), and costs of the Attorney General's Office ("AGO") outside of the ordinary operational expenses of the Department of Justice.

These settlement amounts are either partial or in full of the Total Claim Amount identified by a Claimant in the claim filed with the Claims Administrator. Other claims have resolved with no settlement amount awarded from the Fund for different reasons, such as ineligibility (e.g., claimant was not living at the time the claim was filed). No claimant has progressed through the conclusion of a Resolution Proceeding as of the end of the 2023 Quarter Two Reporting Period.

<u>Report Note:</u> 2023 Quarter One Report contained a numeric error that is corrected in the calculations for the 2023 Quarter Two Report. Specifically, the Amount of the single claim approved for payment in Quarter One is **\$170,000.00**, not "\$170,00.00."
